

ORDINANCE NO. 2019-05

Adopting an Amendment to the Town of Kewaskum Comprehensive Plan

The Town Board of the Town of Kewaskum, Wisconsin, do ordain as follows:

SECTION 1. Pursuant to Section 62.23, section 61.35, and Section 60.22(3) of the *Wisconsin Statutes*, the Town of Kewaskum is authorized to prepare and adopt a comprehensive plan as defined in Sections 66.1001(1)(a) and 66.1001(2) of the *Wisconsin Statutes*.

SECTION 2. The Town Board, by the enactment of an ordinance, formally adopted the document titled "A Comprehensive Plan for the Town of Kewaskum: 2035" on October 19, 2009.

SECTION 3. The Plan Commission by a majority vote of the entire Commission at a meeting held on August 19, 2019 recommended to the Town Board the adoption of an amendment to change the land use designation of a parcel of land located on Forestview Rd., Tax Key T8-0260 from Agricultural Preservation to Agricultural/Open-Space on the land use plan map adopted by the Town Board as part of the comprehensive plan.

SECTION 4. The Town published or posted a Class 1 public notice and held a public hearing regarding the plan amendment.

SECTION 5. The Town Board of the Town of Kewaskum hereby adopts the attached Amendment No. 6 to the Town of Kewaskum Comprehensive Plan: 2035.

SECTION 6. The Town Clerk is directed to send a copy of the plan amendment to the parties listed in Section 66.1001(4)(b) of the *Wisconsin Statutes*.

SECTION 7. This Ordinance shall take effect upon passage by a majority vote of the full membership of the Town Board and publication or posting as required by law.
