Chairman Scott Wollner reported that on South Mill Road, Payne and Dolan is about two weeks behind on the South Mill Road project and will finish in October. The town will shoulder the road.

Mowing is done in the town; the mower is needing some work.

A culvert was replaced on Ridge Road.

There was storm damage on Sunday night on East Moraine and Kettle Moraine roads. Trees fell from state land, and there was some damage on signs.
